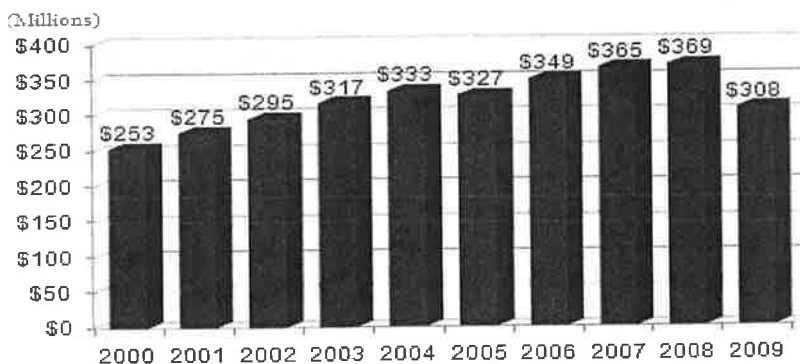

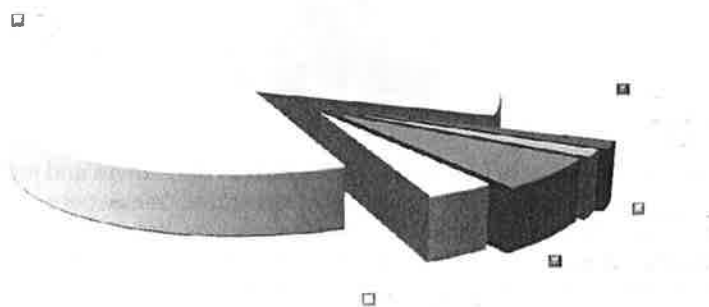

## DIVERSIFICATION OF ASSETS YEAR-END 2009




