1. When-Saturday June 29, 2019.
2. Where-Piper Glen Golf Club. 7112 Piper Glen Drive, Springfield, IL 62711. Course is off Illinois Rte. 4 approximately 2 miles south of Interstate 72.
3. Start time for golf-1:00pm. Lunch available at 12 noon.
4. Events-Four Man Scramble teams, drop out. No handicap needed for teams. Singles Competition participants must declare a handicap. Ladies 4-person teams may enter if sponsored by a Council.
5. Cost-\$75 per golfer. All checks for fees made out to Illinois State Council. Cost includes greens fee, cart, lunch, prizes.
6. Eligibility-This is a team competition and individual competition. An Illinois Knights of Columbus council is to sponsor the participating team. Teams consist of four participants. A minimum of 2 of the team participants **must be current members** of the Knights of Columbus, in good standing. Signed 2019 travelling cards are proof of membership. The two remaining participants, if not members, are guests of the sponsoring council. **For singles competition all participants must be Knights of Columbus.**
